Responsibilities of Safety Patrol Members:

- Children are “on duty” during arrival/dismissal times
- Monitoring entrances and hallways
- Assisting bike and scooter riders at the bike racks
- Assisting teachers in supervising the cafeteria and gym prior to the a.m. bell
- Raising and lowering the flag
- Greeting arriving children in the carpool circle
- Greeting arriving children at the bus drop-off
- Verifying halls are clear at the end of the day for bus departure

P.M. Session – 2:40-3:05

Dates: Every day for one 4 to 6-week session, EITHER a.m. or p.m.

Assignments: Assignments are made by the parent-volunteer, taking into account the a.m./p.m. preference indicated on the form and schedules for Recycling Club and Choir Practices.

Parent Help: None, unless you would like to volunteer. We can use a photographer to show up once per session to make sure we get pictures of all the kids. There will also be a pizza party at the end of the year in RES cafeteria. We could use a volunteer to put it together and one or more to help set up and serve.

Transportation Issues:

- Children assigned to a.m. duty should be dropped off at 7:35 a.m. for duties.
- Children assigned to p.m. duty should be picked up at 3:05 p.m. after buses leave.
